Mr. Rusty Dreher and Mr. Ryan Conkle-Dog License Increase

At 9:00 a.m. Mr. Rusty Dreher, Dog Warden and Mr. Ryan Conkle, Assistant Dog Warden discussed with Commissioner Shryock and Commissioner Conkle the need to increase the Dog and Kennel Registration fee for the 2023 year. They are requesting to increase the Dog Registration Fee to \$15 from \$12 and the Kennel Registration Fee to \$75 from \$60. Mr. Dreher stated his office reached out to each county in Ohio to find out what their Dog and Kennel Registration Fee's were and they found the State average was \$16. Mr. Dreher also stated that his office has seen an increase in cost in the office with Personnel, equipment, fuel and the Animal Shelter. The increase in fees per year would generate an additional \$30,000.00 yearly. Mr. Dreher also reminded the Commissioners that 15% of the Dog and Kennel Fund goes directly to the Auditors office for the selling of Dog and Kennel Registrations. Mr. Shryock thanked both Mr. Dreher and Mr. Conkle for their work and both Commissioners agreed to sign Resolution 2022-056, a resolution to increase the fees as stated above.

Bid Opening – Village of West Lafayette Flood & Drainage Facilities Project

At 9:30 a.m. bids for the Village of West Lafayette Flood & Drainage Facilities Project were opened with the following persons in attendance: Mr. Don Well, William Albert, Inc., Mr. John Cleek, CDC of Ohio, Mrs. Tammy Hicks, Village of West Lafayette and Mrs. Dana Gosbill, Kinsey. Mr. Shryock read the following bids aloud: Kinsey Excavating, New Philadelphia, Ohio with a bid of \$637,719.87 and William Albert Inc., Coshocton, Ohio with a bid of \$668,011.60

Mr. Conkle made a motion, seconded by Mr. Shryock to turn over all bids for the West Lafayette Water and Sewer Line Project for their review and recommendation to Mr. John Cleek of CDC of Ohio. Provide to Engineer to review.

At 9:45 a.m. Mr. Shryock made a motion, seconded by Mr. Conkle to go into executive session with Mr. Rusty Dreher to discuss personnel matters. All vote aye. No action taken. At 10:00 a.m. the meeting was returned to regular session.

At 11:30 a.m. Commissioner Shryock and Commissioner Conkle attended the Ground Breaking for the new EMS Facility at the corner of Walnut and 7th Street along with Mrs. Mary Beck, County Administrator, Mr. John Cleek, CDC of Ohio, Mrs. Hannah Diwald, CDC of Ohio, Mr. Miller from Classical Construction, Mr. Todd Shroyer, EMS Director, Rick Cosmor, EMS Captain, Mr. Ty Stewart, EMS Captain and Miss Kayla Chapman, EMS Captain. Mr. Shryock thanked everyone for coming and gave special thanks to John Cleek, CDC of Ohio for his assistance in grant writing that helped the county obtain 1.95 million dollars in CARES ACT money out of the Department of Development. Mr. Shroyer stated he is thrilled for this ground breaking today as it is a long time coming for the county.


