Sheriff Crawford-Central Square Software

At 9:00 a.m. Sheriff James Crawford spoke with the Commissioners in regards to his earlier request to sign a contract with Central Square Software sooner rather than later so that they may begin to look at the blueprints of the new Justice Center to adequately prepare move/new 911 consoles and equipment. Mrs. Robin Schonauer stated that the Central Square representative has reached out to her via email twice and would like to know the counties stance with this contract. Sheriff Crawford stated in his opinion he would like to get this process started now, as he believes that it will help alleviate issues down the road during final completion of the Justice Center. In addition, the Sheriff is concerned about supply chain issues and the timing of

receiving vital 911 equipment. Annually there is \$203,000 unencumbered in the 911 budget, after signed the Central Square contract that would leave the fund with roughly \$70,000. Mrs. Schonauer stated that at the end of 2023 there will be an additional \$35,000 freed as well as another \$50,000 in 2025 in monies that come out yearly for payments in the 911 fund. There was general discussion of a new 911 levy as well. The Commissioners' thanked Sheriff Crawford for his information and told him to go ahead and move forward with the contract.

## Executive Session-Opioid Settlement Update




