Mr. Jed McCoy-DJFS Children Services Levy

Mr. Jed McCoy, Director of Job and Family Services attended the Commissioners meeting to discuss the possibilities of putting an additional levy on the May ballot to help cover the cost of Foster Care. Mr. McCoy stated that a 1 mill levy would bring in an additional \$849,137.00 in funds to help cover the cost of the foster care program. The current levy is collected at the 1990 rates. Currently DJFS brings in 2.4 million and spends a little of 3 million, leaving a shortfall of \$570,000. If the additional levy was passed along with the currently levy, a little over 1.2 million dollars would be collected. Mr. McCoy is looking into avenues that would allow JFS to be more proactive rather than reactive, such as, an outreach worker within the school systems. This program would allow for teachers and students to work closely with the outreach workers on students and family's needs, elevating the need to call in DJFS. Currently, there are counties who are working with the schools in this manner and those counties have seen a decrease of foster care within their county. As of today, 45 kids are in foster care and the cost to care for these kids are out of their control. Many kids within the foster care system have numerous health care needs as well as mental needs, the cost associated with those needs continue to rise. McCoy reported that there is one foster care client who has over a quarter of a million dollars in cost associated with his needs in the foster care system. Unfortunately, even when the numbers of those in care decrease, their needs increase. The Commissioners thanked Mr. McCoy for all of his information.

# Meetings attended

Friday, January 12, all three Commissioners attended the CFLP meeting in Licking County and after that meeting Mr. Shryock attended the CFLP Policy Committee meeting. Lastly, Mr. Shryock attended the Appalachian Committee Stack Holders meeting on Thursday, January 12.
