## Coshocton County Engineer's Office-County Road Vacation Discussion

Mr. Fred Wachtel and Mr. Josh Kempf met with the Commissioners to discuss two (2) County Road Vacations that they would like to initiate in the near future. The first County Road that the Engineers office would like to initiate a petition for would be CR 496, this road is just pass Skips Landing and serves three (3) homes and business. Mr. Kempf has already spoke to the business owner and they are in support of the road vacation. The entrance/exit into Skips was discussed, as this may be moved, however until the Ohio Appalachian grant is awarded this will not take place. Mr. Wachtel questioned if the Commissioners were in favor of the County Engineers office imitating the process to start the road vacation? Mr. Shryock asked if this vacation would effect a possible round-about in the future, to which Mr. Wachtel stated, "no, would own all of the area now. Mr. Wachtel also stated that the City property at the end of the peninsula would still be able to be accessed via public easement access if needed. Mr. Conkle and Mr. Fischer both agreed to start the process for this road vacation. Mr. Wachtel will start the process of vacation of said road. Next, Mr. Kempf talked about the vacation of County Road 116, this only services three properties, additionally Mr. Kempf has not spoken to the land owners yet but will reach out to them in the near future. Mr. Wachtel stated the road is in good condition and is no benefit to the public. Mr. Shryock wants to hear what the landowners have to say about the possibility of the road vacation. Mr. Shryock thanked the both of the gentlemen for their time.


