Buckeye Brine-Suzie Patterson

Ms. Susie Patterson stopped in to introduce herself to the Commissioners as the new manager of Buckeye Brine, as Mr. Steve Mobley has retired. Upon her arrival to introduce herself, she informed the Commissioners that within the next two weeks that Buckeye Brine would be taking twelve (12) truckloads a day of treated water that was of drinking standards for the containment in question, less than 2 parts per billion and approved by Ohio EPA and US EPA from East Palestine, Ohio via Norfolk-Southern incident. The Board expressed their dissatisfaction of that decision and the impact that it could potentially have on our community. Ms. Patterson stated that this has been in the works for 6 months and that the Ohio EPA believes this facility is one of the best facilities to accept that waste, additionally the treated water in question will be tested and analyzed four times by one lab before it is injected in the well. Mr. Shryock asked if this is drinking water standard, then why would it have to be injected in the ground? The Commissioners let Ms. Patterson know that they have previously wrote a letter of opposition in regards to the wells. Mr. Shryock also stated this is nothing more than a liquid landfill in our community. The Commissioners believe this news is detrimental to the image of this community. Additionally, the Commissioners expressed their concerns of a potential accident on the road at the intersection of CR 621 and Airport Road could significantly impact Genesis Hospital, The Armory, Hopewell Schools, and how that would impact our community.
