General Discussion-Public Input

Mr. Tom Hawk stopped in to discuss OhioTT with the Commissioners as he was approached by their land agent to put a tower on his property in the Barkersvill area. He acquired as to who would sign the land lease if he would allow a tower to be constructed on this property. Mr. Shryock addressed this concern, as he stated the contract would be signed by OhioTT not the Board of Commissioners. Mr. Hawk was not pleased with the respect or knowledge from the land agent who was working for OhioTT. Mr. Shryock gave a brief update as how they came to have a contract with OhioTT through RFP's. Mr. Hawk stated that OhioTT offered him \$500/month to install a 180-foot tower on his land, he is wary of working with OhioTT and will give this contract some thought for the benefit of the whole area of Bakersville. Mr. Shryock thanked Mr. Hawk for his time and information.

Public Viewing, TR 1500, Adams Township

At 10:00 a.m. the Commissioners attended a Public Hearing of TR 1500, in Adams Township with the following people present: Mr. Dane Shryock, Commissioner, Mr. Gary Fischer, Commissioner, Mr. Rick Conkle, Commissioner, Mr. Joshua Kempf, Deputy Engineer, Mr. Sam Mullett and Mr. Bruce Lane. Mr. Kempf stated the Public Viewing by stating the road vacation would only be from CR 93 to the other side of the bridge, as the road on the other side of the bridge is an abandoned road, in class X. Mr. Kempf also stated that the County Engineers office is willing to put culverts for the bridge once the vacation is final. Mr. Mullett is not in favor of the vacation and would like to see the bridge fixed correctly and left open. Mr. Kempf stated that the funding is not there to fix a bridge that only serves two properties. Mr. Conkle asked if the creek floods, to which Mr. Mullett stated, "not really". Mr. Kempf also stated the township trustees are fine with this vacation as well. If the vacation is not granted the bridge will be pulled as it only serves fields. Mr. Lane inquired about all the money that has been allocated toward TR 1500 over the years, as to where it has gone and what is has been spent on. Mr. Lane is not in favor of the vacation and will get an attorney. Mr. Kempf spoke that federal government either wants the road vacated or the bridge taken out, if the road is vacated, the bridge will still be able to be used. Mr. Lane is concerned if the road is vacated that it would de-value is land. Mr. Mullett questions as to why that can't find another bridge to replace the one in question on TR 1500. Mr. Shryock stated in closing that the final decision will be that of the commissioners and thanked the gentlemen for their input. Mr. Kempf stated in closing that the only reason this vacation is being brought up is that the Federal Highway sees any bridge over 10 feet as the responsibility of the County Engineer and a public bridge, that they have deemed "unsafe", however they have offered no money to fix it. Mr. Conkle asked about the cost to fix the bridge, Mr. Kempf gave a figure from \$130,000-\$200,000. Additionally, Mr. Conkle encouraged the gentlemen to go to a trustee meeting to voice their concerns. The Public Hearing for this road vacation will be on Monday, September 25th.

Bid Opening

At 11:30 a.m. there was a bid opening for the CDBG Neighborhood Revitalization, Basketball Courts with the following people present: Ms. Hannah Diewald, CDC of Ohio, Mr. Joshua Kempf, Deputy Engineer and Mrs. Robin Schonauer, Budget Director. No bids were submitted for this project.

Report of Meetings Attended

Mr. Fischer attended the Annual Chamber Dinner on Friday evening. Mr. Shryock had lunch with McWane Ductile on Wednesday afternoon in regards to the River Walk dedication, on Thursday afternoon Mr. Shryock also had a planning meeting with OHM in regards to the Appalachian Grant Dollars and on Friday evening Mr. Shryock attended the Chamber dinner as well, at the dinner Mr. Shryock and Mr. Fischer presented both Todd and Terry Shroyer with the First Responder of the Year Award.


