Mr. Mark Kowalski, Coshocton City Schools Superintendent Introduction

Mr. Mark Kowalski attended the Commissioners meeting to introduce himself as the new Superintendent for Coshocton City Schools. He briefly discussed the needs of a new 7-12 grade building and how there will be an issue on the ballot for those needs. Additionally, the redistricting in Ohio was brought up for discussion, as Coshocton is now with all of Holmes County and half of Knox County (including Mt. Vernon). Mr. Shryock shared with Mr. Kowalski, about how Montrose has been very beneficial to the county in finding funding for projects on behalf of the County. Mr. Kowalski stated that currently they are working on funding for the tennis courts, which is in need of repair/replacement. Mr. Kowalski is very appreciative of all the work the Commissioners are doing for the betterment of the County, such as the McWane River Walk. Lastly, Mr. Kowalski references that five (5) people are running for three (3) board seats. Mr. Kowalski thanked the Commissioners for their time this morning.

## Report of Meetings Attended




## Recess

At 10:30 a.m. Mr. Shryock recessed the meeting.


