Discussion - Pictometry - County

Mr. Grant Daugherty and Mr. Jarrod Tipton, County Auditor's Office attended the meeting to discuss a change to the County-wide Pictometry Agreement with Eagle View. Mr. Tipton explained that they had been approached by Eagle View to provide straight down imagery in the off years of our contract. Typically, they fly every 3 years and we get a panoramic image. With this added we will be able to get an additional straight down view every other year now. He stated that so far in going over 16% of the new view, he has found 10.8 million dollars in additional real estate. This will definitely benefit the county in the long run. Mr. Daugherty stated that for the first few years we should be able to add a lot of additional tax values. However, this will also save monies as we won't need to be out driving around in the county any longer either.
