Mr. Frederick T. Wachtel, Discussion

At 9:00 a.m. Mr. Frederick T. Wachtel spoke to the Commissioners about this joint purchase agreement for equipment with two other counties; Tuscarawas County and Carroll County. This joint equipment agreement is for a tree trimming Graff-boom vehicle that can reach 70 feet high to cut limbs, this is being sold by Frontier Power of Coshocton. Ben Hall, Coshocton County Prosecutor has read the agreement and is ok with it as well. Tuscarawas and Carroll Counties are both presenting this joint agreement to their commissioners as well, Tuscarawas County will be the lead in the bidding process. This piece of equipment is more efficient for the counties to use during the months of November-March. Mr. Shryock asked if the townships would be able to utilize this piece of equipment to which Mr. Wachtel stated, yes if a County Engineer personnel was using the equipment. The Commissioners signed off on the agreement.

Executive Session-Selling of Property


