EMS General Discussion

At 9:30 a.m. Mr. Todd Shroyer, EMS Director, Ms. Kayla Chapman, Assistant Chief of Administration and Mr. Joe Hunt, Assistant Chief attended the Commissioners meeting to discuss the following: Mr. Shroyer is working with billing company to create an insert that will be added to the bills that patients will begin receiving from April services, this insert will give a brief update in regards to why patient responsibility amounts are being collected. Additionally, those who receive bills will also be able to apply for a hardship, this method will be the same that hardship policy that hospitals utilize. Those patients with a Medicaid policy either as primary or secondary will not receive invoices for EMS services as they are not able to be balanced billed for any services rendered. Mr. Shroyer is still working on a date for the EMS Open House that will be held sometime in May. Mr. Shroyer has spoken to the crews to assure them that none of them who are fulltime are losing their jobs. There will be some crew members retiring within the next few months and currently when there are call-offs and scheduled vacations those positions are not being filled. All stations will have a crew during the day, said Mr. Shroyer. Mr. Shryock stated that the EMS issues are not all on Mr. Shroyer's shoulders, these repercussions are from the voters. Mr. Shroyer passed along legislation news that was passed in the Ohio budget in regards to Medicaid dollars, this legislation was added to the budget thanks to Representative Kick. This legislation will be very beneficial to Coshocton EMS, as 30% of calls are those with Medicaid coverage. Currently, there is no timeline as to when this will be effective. Coshocton County EMS has 55 full/part time employees currently, those who are looking at retirement have 30+ years of service with EMS. Mr. Shryock stated in closing that Coshocton EMS has the full support of the Commissioner's office.
