Mr. Brad Fuller, Good Boy Bakery came to the Commissioners meeting to discuss the upcoming Dog Fest that will be held on August 17th at Lake Park from 10:00 a.m. until 6:00 p.m. This event will host three (3) major events for the public to watch; Dog Dock Diving, Ultimate Air Dogs and a Lure Course. In addition to the events, vendors will be set up all day as well-Roscoe Village will also have a Food Truck Festival going on at the same time, CCCTA will be available during the day to provide transportation back and forth from Roscoe to Lake Park. Mr. Fuller has partnered with Friends of the Park and has received grant funding from Coshocton Foundation in the amount of \$8700.00 for the start of cost of hosting this event. Mr. Fuller would like to see this festival be an annual festival, all proceeds from the event will go to the Coshocton County Animal Shelter. Mr. Fuller is not currently looking for donations from the Commissioners but he advised that formal donation letters will be going out in the mail soon. Mr. Fuller is excited for this fun community event and hopes to raise \$10,000.00. Community feedback has been great for this event and there are so many ready to volunteer to help make this event successful. Mr. Shryock thanked Mr. Fuller for his time and expressed how donations are hard to give with tax base funds.


Mr. Conkle attended the Family Children First Council on Tuesday, April 16th.
