Public Hearing #2, Coshocton County PY 2024 Public Hearing

At 10:00 Mr. Shryock opened the Public Hearing #2, CBDG Critical Infrastructure-City of Coshocton with the following people present: Mr. Shryock, Mr. Fischer, Mr. Conkle, Mrs. Beck, Mrs. Schonauer, Mrs. Jillian Flowers, CDC of Ohio, Mr. Dave Kadri, City of Coshocton and Mr. Chuck Selders. Mrs. Flowers started the hearing stating that this PY 2024 Critical Infrastructure Grant will assist the City of Coshocton with their Water Facility Improvements, in the amount of \$500,000(\$470,00-improvements and \$30,000-administration) an additional \$596,000 in funds will come from the City of Coshocton to complete the project as a whole. The grant will assist the City of Coshocton with their water facility improvements projects that entails the replacement of electrical services lines from the well field to the water treatment plant and electrical equipment upgrades at the well field. This project is critical for the residents as well as for fire protection to the City of Coshocton, West Lafayette and to come Warsaw. Mr. Kadri was late to the public hearing himself this morning due to power issues at the water plant this morning, he is pleased as to how the project is moving along well, with estimates close to earlier projections. Mr. Shryock asked about generators to power the plant in case of outages, to which Mr. Kadri stated three Generic Generators were just purchases for emergencies. Mr. Shryock thanked Mr. Kadri for his time.

Public Hearing #4, Coshocton County PY 23 Opportunity/Flex Program

At 10:30 Mr. Shryock opened the Public Hearing #4, CBDG PY 23 Opportunity/Flex Program with the following people present: Mr. Shryock, Mr. Fischer, Mr. Conkle, Mrs. Beck, Mrs. Schonauer, Mrs. Jillian Flowers, CDC of Ohio, Mr. Eric Exley, and Mr. Chuck Selders. Mrs. Flowers started this hearing stating the PY 2023 Target of Opportunity/Flex Grant will assist the City of Coshocton with Pickleball Courts in the amount of \$250,000(\$240,000 for the courts and \$10,000 for administration) an additional \$25,000 will be needed for the completion of this project, those funds will come from the Pickleball Club. This project will be an expansion to the four (4) courts that are current used, Coshocton County will be the only place in Ohio where you can begin a Pickleball tournament outside and move it inside to Kids America if needed due to weather. Additionally, this project has the potential to bring in more tourism to the community as these tournaments draw players from all around Ohio. Mr. Shryock stated that these tournaments are a great benefit to our local restaurants and hotels. Mrs. Flowers is confident in this grant. Mr. Shryock appreciates Mrs. Flowers professionalism as well as the working relationship she and CDC of Ohio has with the state. Mrs. Flowers stated in closing that the application for the grant is due on June 17th and once Mr. John Cleek, CDC of Ohio has reviewed the application, she will then send it on next week to the state for processing.

Mr. Caleb Shriver, JD Vance Representative

At 11:00 a.m. Mr. Caleb Shriver introduced himself to the Commissioners as Senator JD Vance's Southeast Ohio Representative. Mr. Shryock believes that this is a tremendous accomplishment locally to represent a United States Senator. Mr. Shryock asked Mr. Shriver is the Senator had anything in particular to talk about, to which Mr. Shriver stated not. Currently, the Senator is behind the affordable connectivity program, that was recently not passed in a bill The Senator would like to see more broadband connectivity in the Appalachian Region. Mr. Shryock spoke briefly on Medicare/Medicaid reimbursement rates that are hurting local EMS's and burdening the community. Medicaid runs make up roughly 30% of the EMS runs in our community and the reimbursement rates are not increasing enough to sustain the life saving measures needed. Mr. Hayhurst, Coshocton Tribune stated that additionally EMS makes a lot of runs to which no transports are had, these no-transport runs are not billed out to insurances or patients and essentially monies lost due to medication and products used during that run. Additionally, Mr. Shryock spoke about connectivity in Coshocton County with Spectrum building out hard fiber lines throughout Coshocton and Ohio, this was made possible due to ARDOF dollars. OhioTT was has an internet project in Coshocton County as well, this project is being complete with ARPA funds and should be done by the end of 2024. Both projects combine have made tremendous strides in the county Mrs. Beck spoke about Federal Dollars for Transportation in regards to foot-bridges, once the CR 621 multi-path is complete Mrs. Beck would like to see a foot-bridge across 36 to the Lake Park area to increase the walking/biking paths (10 miles of trails). The foot-bridge would allow better and safer access across the highway, as the highway is to large for a crosswalk. Mr. Shryock also spoke about the need to have the 4-lane complete in Coshocton County; he believes this will take some federal push to make this project happen. Mr. Shriver is taking back to Senator Vance three (3) key needs in Coshocton County;4-lane, EMS rates and a foot-bridge. In closing, Mr. Shryock stated that Coshocton County has been very successful with grant applications with state money in the last 10 years for the needs of the County. Mr. Shryock is also glad to have a Coshocton native representing the County.
