Public Hearing, 2025 Budget

At 9:00 a.m. Mrs. Robin Schonauer, Budget Director and Mrs. Cortnie Jamison, Administrative Assistant presented the 2025 Budget to the Commissioners. The General Fund budget for the 2025 year is \$18,933,965 and the Non-General Fund budget for the 2025 year is \$47,512,213 for a county total of \$66,446,178. Mrs. Schonauer stated this is only a guide for the budget next year, when January comes, she will have a better idea if departments will be able to receive their full request. A meeting in September is being planned to discuss budget needs for next year. Additionally, she stated that no large expenses are expected for 2025 other than the additional employee at the Justice Center.
