Road Vacation Discussion, Cooper Street, Jefferson Township

At 9:00 a.m. Mr. Shryock opened the floor for the continued discussion of the road vacation of Cooper Street in Jefferson Township. In attendance were: Mr. and Mrs. Kackley, Mr. Joshua Kempf, Deputy County Engineer and Mr. Bob Bigrigg. Mr. Shryock spoke about a legal opinion the Commissioners were in receipt of from the County Prosecuting Attorney, Mr. Ben Hall, which states: does land go to the landowners inside the subdivision or do landowners outside the subdivision also get part of the vacated land? The Relevant Ohio Revised Code statues make clear that the vacated road portion or portion of the road shall pass, in fee, to the abutting landowners. The case cited specify that the landowners outside of the subdivision are entitle to their share of the vacated road or alley, the inverse of this would also be true, which means that if the road of alley are outside of the subdivision the abutting landowners inside the subdivision would be entitle to their portion of the vacated road or alley. It was asked of the Kackley's if the road was there in 2017 when they bought the property. Mrs. Kackley stated, yes and they have maintained the road since then, as it is dangerous for them to back out onto SR 79 to leave their property. The Kackley's do not want the road vacated if the adjoining landowner will receive half of the road. Ohio Revised Code (ORC) states that if the road was not improved by the governing agency, for 21 years after plotted, it shall be vacated. With that being said, Mr. Shryock has questions on who improved the road. Mr. Shryock asked if Mr. Kempf had any advice for the Commissioners? Mr. Kempf, stated that he cannot offer any advice and suggested trying to reach back out to Mr. Hagans, sho is the adjoining landowner for his thoughts. Additionally, Mr. Kempf stated the township is not receiving any funds for this road as it is not on their annual mileage. Discussion was had about the ability to put this road in Class X. Mr. Conkle at this time does not think the Commissioners should vacate the road. Mr. Kackley stated that he has concerns on the survey of the property as well and if the survey is correct or not, as this could help or hurt the vacation of this road and his property. Mr. Shryock stated the easy answer is to vacate, but we are a country of property rights traditionally. Mr. Kempf stated he does not agree with the Prosecutors opinion. Mr. Kackley is willing to share the driveway with Mr. Hagans, however he does not want to be blocked off at the corner of his lot. An easement between the Kackleys and Hagans would be the easiest thing to do. Mr. Bigrigg asked if Mr. Hagans use the road and it was stated that he only enters his field at the opening of the road. A decision needs to be made by August 7th. Mr. Shryock will try to reach out to Mr. Hagans for further discussion. Mr. Shryock, Mr. Fischer and Mr. Bigrigg will drive out the road this afternoon with Mr. Kempf to take another look at the road and survey pins before a final determination is made. Mr. Shryock said in closing, property rights are the founding rights of this country and important to all. If no decision is made by the Commissioners this action will go back to the township to decide.

Road Vacation Viewing, Buck Alley, Tuscarawas Township

At 10:00 a.m. the Commissioners attended the Public Road Vacation Viewing of Buck Alley, Plat of the town Of Lewisville (n.k.a. Canal Lewisville) in Tuscarawas Township with the following people present: Commissioner Dane Shryock, Commissioner Gary Fischer, Commissioner Rick Conkle, Mr. Bob Bigrigg and Mr. Larry Wilkin. Mr. Larry Wilkin was the only person present from the public, he stated that all the landowners were in favor of this vacation. No other discussion was had, Mr. Shryock thanked Mr. Wilkin for attending.
