#### Collection of Court Fees-Ms. Camila Graham, Clerk of Courts

At 9:00 a.m. Ms. Camila Graham, Clerk of Courts and Ms. Arica Sapp, Clerk of Courts attended the Commissioners meeting to discuss the agreement that the Clerk of Courts would like to implement in conjunction with the Attorney General's Office to collect delinquent courts cost, such as fines and restitutions. Currently, past due notices are sent locally from within the Clerk of Courts office with a letter from the Prosecutors office. Ms. Sapp ran a report for delinquent court fines that are still owed for the last 10 years to current with a total of \$200,000 in fines that could be potentially collected, as the Attorney General will only collect on cost within a 10-year timeframe. Working in conjunction with the Ohio Attorney General will allow delinquent court cost to be collected from State tax refunds, casino winnings and sports gambling earnings as well. The Clerk of Courts Office will not have a share of the cost deducted from the fines collected, as there will be a 10% fee added to all court cost owed for the individual to pay on top of the fines owed. Initial set up of the program will cost \$3,100.00, Ms. Graham stated she has this money already allocated in her current budget. Ms. Graham stated in closing that is program has been in place out of the Attorney General's office with other surrounding counties utilizing it and she believes this will be a great benefit locally.

#### Agreement with Ohio Attorney General and Clerk of Courts

Mr. Fischer made a motion, seconded by Mr. Bigrigg to sign the Delinquent Debt Collection Agreement between the Ohio Attorney General and The Board of Coshocton County Commissioners for the collection of delinquent debts owed to Coshocton County, pursuant to Ohio Revised Code 131.02., such as court cost, fines and restitutions, at the request of Ms. Camila Graham, Clerk of Courts.
