Public Hearing - Road Vacation

At 9:00 a.m. Mr. Shryock opened the Public Hearing for the road vacation of Linn/7th Street in Tuscarawas Township with the following people present: Commissioner Shryock, Commissioner Fischer, Commissioner Bigrigg, Mrs. Mary Beck, County Administrator and Mr. Tom Crawford, McWane Ductile General Manager of Ohio. This Road Vacation Petition was filed by the Tuscarawas Township Trustees. Mr. Shryock asked if there were any comments to make. Mr. Crawford just confirmed again the road vacation details, to ensure correct placement of the new property fence that will be moved and placed. Mr. Shryock thanked Mr. Crawford for his attendance this morning during the public hearing.

Commendation-Mr. and Mrs. Fehrman

At 10:00 a.m. Mr. Bigrigg read and presented the Fehrman's with a Commendation. Mr. Shryock thanked the Fehrman's for helping to Revitalize Christmas Connections for those in the Community. Mrs. Fehrman thanked the Commissioner for the Commendation but stated it was not necessary as she believes in serving the community. Mr. Fehrman said the best part of portraying Santa was when he had a true believer on his lap during the season Mr. Fehrman stated in closing that he will once again next year continue his serves of portraying Santa Claus for those in the Community and donating the funds to the Courthouse Illumination Committee Project.

Department of Job and Family Services Levy Discussion

At 10:30 a.m. Mr. Jed McCoy, DJFS Director and Mr. John Piper, DJFS Fiscal Administrator attended the Commissioners meeting to discuss the upcoming renewal of the DJFS levy in the spring. Mr. Shryock began by asking, what does this levy fund? Mr. McCoy stated that this levy only funds placement cost for children in foster care facilities, such as: residential facilities or group homes. Additionally, Mr. McCoy stated that cost such as the room/board, meals, clothing, anything you would need to pay for a normal child is not covered under Medicaid services. In December 2024 DJFS paid our \$244,00 in cost alone for these services, currently 8 children cost over \$10,000/monthly. Mr. Piper said that 2.6 million dollars was spent in 2024, which is up from the 1.8 million spent in 2023. If DJFS would put a renewal on the ballot, this would generate \$475,000. Unfortunately, there is a lot of misunderstanding as to how levy funds are spent, and Mr. McCoy once again stated these funds generated by the levy can only be spent on the children. This issue is not just locally, it is being seen statewide and nationally. Mr. McCoy also stated there is not much that can be done to help curb cost, as they have no control over cost. January of 2023, DJFS only had 35 kids in their care and as of today they currently have 73 kids in their care. DJFS currently has custody of a child that Mr. McCoy had to call over 200 facilities within the US to find a placement for this child, however due to the needs it was hard to find a placement, this child is now in a facility in Arkansas. Mr. McCoy stated these kids deserve the best care to become healthy. Mr. Shryock asked how additional funds are received in their office for all the services needed. Mr. Piper said that DJFS received State Allocations, 4E reimbursements/federal dollars (using 1996 family eligibility guidelines), shared agreements with local courts, Board of DD and Mental and Health Recovery Boards. Shared agreements help pull funds together and save money across the board for all agencies. 2025 is the last year of collections for the current DJFS levy, which is using 1995 evaluations for funds collected on this 1 mill levy. Mr. McCoy stated in closing that this levy is a critical need for his agency, however he understands that the additional and replacement levies were voted down by the community, so he will work with the renewal and do what he can within his budget. Mr. Bigrigg stated that really there is no other choice but to put the renewal on the ballot, Mr. Fischer agree that a renewal would be the best opinion right now. A renewal certification will be placed on Monday's agenda. Mr. McCoy will continue to work together and be proactive for the children. Mr. Shryock appreciates both gentlemen working to find money elsewhere, additionally in closing Mr. Shryock stated that it is the responsibility of society to raise these kids.
