Executive Session-Opioid Litigation Update

At 8:45 a.m. Mr. Fischer made a motion, seconded by Mr. Bigrigg to go into executive session to discuss Opioid Litigation Update. All vote aye. At 9:00 a.m. Mr. Shryock returned the meeting to regular session. No action taken.

At 9:00 a.m. Sheriff Walters, Eric Demattio, Rusty Dreher and Robin Schonauer attended the Commissioners meeting to discuss the need to purchase new Motorola radios. With the purchase of new radios, old radios will then be cycled out of service, saving the \$10 monthly fee on each. There has been a challenge in the past with the radios used by the auxiliary, and with the purchase of new radios, some of the older radios can be given to the auxiliary to use within their group and also allow for them to be on the same platform of everyone else. Mr. Shryock asked if there was a number of radios worked out as to what was needed. Sheriff Walters stated that 18 radios will be purchased from the city funds and 17 will be purchased from the county funds. Currently, until the end of March the radios are 40% , so Sheriff Walters would like to have the go ahead today to place the order. Mrs. Schonauer recommends that the radios are purchased outright, rather than leasing-as the leasing has additional charges added into the cost. Mr. Dreher believes that the county can recoup some money by selling the radios. Mr. Shryock asked who/how the radios would be cleared of information. Mr. Dreher will be charge of this task. Mr. Bigrigg asked if the radios were going to be sold on GovDeals. Per Mr. Dreher, he would like to first offer them out to the local public safety agencies and what is left over then can be sold on GovDeals. Moving forward for inventory control, Mr. Troy Bricker will be handling the sign-out and logging of all radios for documentation purposes. Mr. Bigrigg agreed that the best option would be to buy them outright rather than leasing. Mr. Shryock asked when the last radios were purchases, per Mr. Dreher it was 2015.

At 9:35 a.m. Mr. Bigrigg made a motion, seconded by Mr. Fischer to go into executive session to discuss Employee Compensation/Resignation. All vote aye. At 10:00 a.m. Mr. Shryock returned the meeting to regular session. The Following Action was taken.

Mr. Fischer made a motion, seconded by Mr. Bigrigg to accept the resignation of Mr. Ryan Conkle from his position of Assistant-Dog Warden effective April 11, 20205.
