### Accurate Controls Contract Discussion

At 9:00 a.m. Sheriff Walters and Lt. Chip Udischas attended the Commissioners meeting to discuss the upcoming Accurate Controls Warranty expiration. Lt. Udischas stated that Accurate Controls is the heart and soul of the jail, as it operates the cameras, doors, alarms, lights, outlets, etc. The warranty for the system will expire on November 25th, if a contract is signed before the November 25th date the price per year for the contract is substantially less. Lt. Udischas recommends the bronze plan, this plan has a cost of \$48,000 to paid over a three (3) year timeframe. The bronze plan provides one (1) annual service visit, online 24/7 telephone technical assistance, and eight (8) hours a year for programming. Lt. Udischas stated he is not looking for action out of the Board of Commissioners today, however, he wanted to bring the issue/contract to the Commissioners now as a potential cost increase for the budget. Mr. Shryock asked if bond money could be used for this contract? Mrs. Mary Beck, County Administrator stated no, that bond money could not pay for a service agreement. Mr. Bigrigg asked if the company was well established, to which Lt. Udischas stated, yes, Accurate Controls won the bid to have the project and are a solid company to work with. Mrs. Schonauer stated that during the June budget that the Sheriff's office will need to reflect this amount in their budget. Mr. Shryock thanked Lt. Udischas for the heads up on this and thanked the gentlemen for their time. Mr. Bigrigg stated that this is great that they are thinking this early out and thanked them as well.

#### Meetings Attended

The Board of Commissioners had conversations yesterday with Mr. Robbie McMasters, EMA Director to make sure he was prepared for the upcoming potential weather forecast for the next 4-5 days. Additionally, the Board of Commissioners reached out to local officials and contracts within the Village of West Lafayette to let them know that the Board of Commissioners will help in any way they are able if flooding were to happen. Lastly, the Board of Commissioners reiterated to Mr. McMasters that they would like to ensure that he was being proactive rather than reactive in the days to follow.
