Mr. Chad Lawrence, Spectrum Elevator Lines

At 9:30 a.m. Mr. Chad Lawrence, IT Director and Mrs. Robin Schonauer, Budget Director attended the Commissioners meeting to discuss the phone lines in the county building elevators as well as fire alarms that are hooked into the phone lines. Currently the county utilizes AT&T for these services, however AT&T is discontinuing their analog phone service. Mr. Lawrence has been working on moving county phone lines over to the counties Spectrum service over the last year and this would be the last moving part to complete the needed change. Additionally, the county is paying \$32.56 a month for this service with AT&T, if we decided to stay with AT&T and update the service this cost would increase to \$164.99/month. Spectrum will offer the same service that is needed in each line for \$30.00/month for the first 12 months and then \$40.00/month after that with a \$99 one-time installation fee. Mr. Lawrence stated that all buildings currently have Spectrum Service so there will be no need for any build outs in the buildings. Mrs. Schonauer and Mr. Lawrence are both in favor of the is change.


