Mr. Nic Bundren, Ohio Land & Liberty Coalition

At 9:00 a.m., Mr. Nic Bundren, representing the Ohio Land & Liberty Coalition, attended the Commissioners' meeting to speak with the Board regarding renewable energy issues and to ask a series of questions about the Commissioners' perspectives on solar and wind development in Coshocton County. Mr. Bundren noted that his organization is conducting an educational, non-profit initiative across the State of Ohio, visiting all 88 counties, with Coshocton being stop number 45. The purpose of the visit was to provide education and foster discussion on solar and wind energy projects. Also present during this discussion was Mr. Joshua D. Kempf, Coshocton County Engineer.

Mr. Bundren explained that his visit was not for profit and not in support of any specific project, but rather to engage local officials in conversation about renewable energy in Ohio. He indicated he would ask four standard questions to guide the discussion:

1. On a scale of 1–10, how would you rate your expertise/knowledge in solar and wind energy?

The Commissioners generally rated themselves around a **4–5**. Commissioner Bigrigg noted he is looking into the possibility of installing solar panels on his own home. It was also noted that the Amish community in the county makes extensive use of solar energy.

- 2. Are there currently any solar or wind projects in Coshocton County that the Commissioners have had dealings with?
- The Commissioners responded that there are no such projects at this time.
 What do you believe the reaction from your constituents would be if such solar or wind projects were proposed in the county? Commissioner Shryock expressed concern that using good farmland for solar projects would upset constituents, though he supports property owners' rights. He suggested that reclaimed strip-mined land would be a more acceptable location for solar development. Commissioner Bigrigg agreed, stating that county residents would likely oppose solar on productive farmland, but might support development on otherwise unusable reclaimed strip mine ground "out of sight, out of mind."
- 4. Do you think renewable energy is a party-line issue or more of a local concern? Commissioner Bigrigg noted that renewable energy tends to be a difficult issue politically, and that other counties have seen officials struggle with re-election after supporting such projects. He observed that a significant portion of the population is opposed to solar panels. Commissioner Shryock added that at the national level, there has been a big push for fossil fuel production, and he feels that solar and wind are not currently sustainable without support from fossil fuel sources. He felt that positions on the issue tend to follow along party voting lines.

Mr. Bundren thanked the Commissioners for their time and insights. The Board expressed appreciation for the educational information and the opportunity to discuss these important topics.
