Meetings Attended

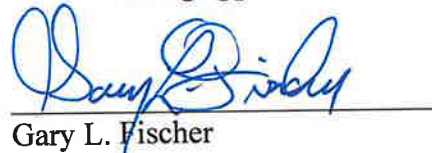
