TIF School Agreement with River View Local School District

Mr. Bigrigg made a motion, seconded by Mr. Fischer to sign the School District Compensation Agreement between Coshocton County Board of Commissioners and River View Local School District, whereas, pursuant to Ohio Revised Code Section 5709.77, 5709.78, 5909.79, and 5709.80, a board of county commissioners may, by resolution, declare the increase in assessed value of parcels of real property to be a public purpose and exempt from taxation, require the owner of each parcel to make annual service payments in lieu of taxes, establish a redevelopment tax equivalent fund for deposit of those Service Payments, to then make payments to school districts affected by that exemption from taxation, and to pay the cost of constructing or repairing public infrastructure improvements directly benefiting said parcels, and whereas, said exemption of any Improvements pursuant to the TIF (Tax Increment Financing) Statutes may only exceed ten (10) years or seventy-five percent (75%) of such Improvement with the approval of the board of education of the affected local school district within the territory of which the Improvements are or will be located and may be exempted for up to thirty (30) years.

TIF School Agreement with Coshocton County Career Center District

Mr. Fischer made a motion, seconded Mr. Bigrigg to sign the School District Compensation Agreement between Coshocton County Board of Commissioners and Coshocton County Career Center, whereas, pursuant to Ohio Revised Code Section 5709.77, 5709.78, 5909.79, and 5709.80, a board of county commissioners may, by resolution, declare the increase in assessed value of parcels of real property to be a public purpose and exempt from taxation, require the owner of each parcel to make annual service payments in lieu of taxes, establish a redevelopment tax equivalent fund for deposit of those Service Payments, to then make payments to school districts affected by that exemption from taxation, and to pay the cost of constructing or repairing public infrastructure improvements directly benefiting said parcels, and whereas, said exemption of any Improvements pursuant to the TIF (Tax Increment Financing) Statutes may only exceed ten (10) years or seventy-five percent (75%) of such Improvement with the approval of the board of education of the affected local school district within the territory of which the Improvements are or will be located and may be exempted for up to thirty (30) years.

Meetings Attended


