The featured speaker this year will be Zac Miller. Miller is an Assistant Veterans Service Officer for the County and recently returned from deployment with the Army National Guard in support of Operation Inherent Resolve.

Also sharing a few words will be Sharon Burns, President of the Blue Star Mothers Chapter OH59.

Patriotic music will be provided by the Walhonding Rube Band.

Samuel Scott, a junior at Kent State University, will sing a rendition of the Armed Forces Medley and TAPS will be performed by local musicians George Clark and Tim Vance, both whom are local veterans.

Members of the Coshocton County Honor Guard will also be performing a rifle salute and representatives from the various local service organizations will be recognized.

Pastor Mike Jansen of the Coshocton Christian Tabernacle will offer the invocation and benediction.



Veterans Day is an official United States federal holiday that is officially observed annually on November 11, honoring the men and women who have served in the U.S. Armed Forces.

It coincides with other holidays including Armistice Day and Remembrance Day, which are celebrated in other parts of the world and mark the anniversary of the end of World War I.

Major hostilities of World War I were formally ended at the 11th hour of the 11th day of the 11th month of 1918, when the Armistice with Germany went ensure they provide a phone number into effect. Veterans to receive 2.8 percent COLA

President Donald Trump recently signed the Veterans' Compensation Cost-of-Living Adjustment Act of 2018.

The new law provides a Cost-of-Living Adjustment (COLA) for the rates of veterans' disability compensation, additional compensation for dependents. the clothing allowance for certain disabled veterans and dependency and indemnity compensation for surviving spouses and children.

VA disability compensation and other

benefits earned through their service, provide a critical lifeline for millions of veterans and their families around the country. The much needed COLA increase made possible by the Veterans' COLA Adjustment Act helps provide



Transportation department outlines new procedures

An update of internal systems by the Coshocton County Coordinated Transportation Agency has led to a few minor changes in their procedures as Veterans utilize services for their Veterans Administration Healthcare appointments.

According to Director Nic Carey, the request process will remain the same as veterans may schedule transportation Monday through Friday from 10 a.m. to 2 p.m. Those who are not already registered may experience some extra wait time as information is entered into the new system.

'The biggest change will be in how clients receive their pickup times," said Carey. "An automated system will now call the client to tell them when the pickup time is. It will leave a voicemail after the third attempt if no one answers.

Veterans should expect to receive these automated calls between 3 p.m. and 3:15 p.m. the day prior to their appointment.

Carey noted that Veterans need to that has a working voicemail. They can also elect to receive text alerts with their pickup times.

Depending on their cell phone plan, texting rates may apply.

Under the law, which is effective December 1, 2018, the new rates for these U.S. Department of Veterans Affairs (VA) programs will be increased by 2.8 percent, the largest increase since 2012 and consistent with the 2019 COLA increase for Social Security.

For a veteran receiving \$1,500 a month in benefits payments, the COLA increase equates to an additional \$500 over the course of the year.

A 1959 graduate of Adamsville High School, he joined the United States Air Force on August 12, 1959 and served over 20 years. After retiring from the Air Force, he also worked at Pretty Products and Kraft Foods before becoming a Service Officer.

He was also a member of the Coshocton County Honor Guard and participated in 570 military funerals.

Jim was a member of the Zanesville Seventh Day Adventist Church, lifetime member of the Disabled American Veterans Chapter 74, Veterans of Foreign Wars Post 1330. AMVETS Post 36, annual member of the American Legion Post 466 and the Military Order of the Cootie (an honorary degree of the VFW).

Holiday food vouchers available to Veterans of Coshocton County

Veterans wishing to obtain food vouchers for the upcoming Thanksgiving or Christmas holiday are encouraged to apply at the Veterans Service Office.

Vouchers will be available to veterans whose annual income does not exceed 200 percent of the 2018 Federal Poverty Guidelines.

Veterans who wish to receive a voucher must provide proof of household income and Coshocton County residency for a minimum of 90 days, have served on active duty for other than training and have been Honorably Discharged.

Each voucher may be redeemed at Aldi's, Buehler's Food Market, Baker's IGA in Newcomerstown, or Collins Meat Market and are to be used for food only.

A list of items that are not to be purchased will be provided to successful applicants and store receipts will be reviewed. Anyone purchasing unauthorized items may be barred from participating in any future voucher programs and/or financial assistance.



This is the fifth year that the Veterans Service Commission and Office are providing these vouchers.

Vouchers will be issued on a first-come, first-served basis as they are limited in quantity.

Ohio Veterans Hall of Fame Class of 2018 announced

The Ohio Department of Veterans Services (ODVS) and Ohio Veterans Hall of Fame Foundation will honor the Ohio Veterans Hall of Fame 2018 Class during its annual Induction Ceremony on Thursday, Nov. 8, at 10 a.m. at the Radiant Life Church in Dublin, Ohio.



Media and the public are welcome to attend. The 20person class will be honored with medals by ODVS Director Chip Tansill and Lt. Gov. Mary Taylor. These 20 outstanding inductees will be honored for their accomplishments and achievements at the 26th annual Induction Ceremony in November for their post-military service.

The Ohio Veterans Hall of Fame was established in 1992 by former Gov. George Voinovich to recognize outstanding professional achievement, service to the community and selfless acts of veterans following their military service.

Charter members of the Hall's Class of 1992 included the six Ohio military veterans who were elected President of the United States and all Medal of Honor recipients from Ohio. Honorees include astronauts, volunteers, community leaders, safety officers, veteran advocates and former government officials.

The Class of 2018 was chosen from among 119 nominations. The inductees, which range in age from 37 to 88, span 13 different Ohio counties and four major branches of the United States Armed Forces – the Army, Navy, Air Force and Marines.

This year's class joins 858 Ohio veterans who have been inducted since inception and represent all eras, branches and walks of life.

Included in previous classes are Edward Lewis Baker and David Dilly of Coshocton County and Vane Scott and Denny Ross of Newcomerstown.

Cleveland, Cincinnati VA hospitals ranked among best performing in nation The Department of Veterans Affairs

released the newest performance ratings Wednesday for each of its 146 hospitals, citing improvements in the past year at some of its lowestperforming facilities.

The fiscal 2018 ratings include nine one-star hospitals, the lowest possible, down from 14 hospitals that received one-star ratings in 2017.

The ratings indicate each hospital's quality of care and are based on data such as death rates, patient satisfaction and efficiency. In years past, the VA had withheld the data from the public. In 2016, the performance ratings were released under pressure that followed a USA Today investigation.

Overall, 38 hospitals improved their star ratings in 2018, 40 dropped in the ratings and 68 stayed the same as last

year.

Hospitals receiving five-star ratings, the highest possible include Cincinnati and Cleveland in Ohio. Columbus VAAAC received a four-star rating and Dayton three stars.

VA hospitals received one-star ratings in 2017 and 2018: Big Springs and El Paso, Texas; Loma Linda, Calif; Memphis, and Phoenix. Four other hospitals were added to the worstrated this year: Montgomery, Ala.; Tucson, Ariz.; Washington, D.C., and Atlanta.

VA hospitals in Dublin, Ga.; Fresno, Calif.; Roseburg and White City, Ore.; Walla Walla, Wash.; Harlingen, Texas; Nashville and Murfreesboro, Tenn., and Biloxi, Miss., improved enough from 2017 to get off the list of lowestrated hospitals.

Eighteen hospitals received 5 stars in 2018, the best possible. Four of them are located in Pennsylvania.

Special Honor Flight to fly veterans on November 11th

Although the last scheduled Honor Flight Columbus excursion to Washington D.C. was completed October 20, another flight that is special will be taking place November 11

Designated as a veterans-only flight, four World War II veterans from across Ohio, including one from West Lafayette will be participating. In all, six Coshocton County veterans will be going on what is Mission #93 and is being sponsored by donations from "grateful Americans".

Honor Flight Columbus accepts applications from America's Senior Veterans. Currently, these are the men and women who served during WWII, Korean, and Vietnam War years. Additionally, terminally ill veterans from any era are put at the head of the line.

Accordingly, WWII veterans will continue to have top priority, with Korean and Vietnam veterans now comprising the majority of each flight. They call the Korean and Vietnam veterans on the waiting list for their flight in the order their applications are received.

The goal to transition veterans of wars by the sequence of the conflicts as long as donations from the public continue.

Earl Morse, the son of a Korean and Vietnam War veteran, and Jeff Miller, a small business owner and son of a WWII veteran, cofounded the Honor Flight Network.

Earl Morse, Physician Assistant and Retired Air Force Captain, worked in a Department of Veteran Affairs clinic in Springfield, OH. After the National World War II Memorial was completed in 2004, he realized many of his WWII patients would not be able to travel to DC to visit their memorial.

Morse, himself a pilot, offered to fly with two veterans to Washington D.C.. In January of 2005, he pitched the idea

to about 300 private pilots at his local Air Force aero club. He proposed the pilots would pay for the flights and personally escort veterans around the city. Eleven additional pilots volunteered.

By January 2005, a board was formed, funds were raised, and other volunteers had joined. In May 2005, six small planes flew 12 veterans to Washington, DC for the first Honor Flight. A combination of small planes and commercial flights were used to transport 126 WWII veterans that first year.

In late 2005, Jeff Miller, a dry-cleaning company owner in Hendersonville, NC, inspired by Morse, had a similar idea but on a larger scale – to charter entire commercial jets. Jeff, the son of a World War II veteran and nephew of a B-24 pilot who died in the war, had been a charter member of the National World War II Memorial Foundation.

Miller was also concerned that local WWII veterans would never visit their new memorial. Miller formed HonorAir and began flying great numbers of WWII veterans from the Asheville Regional Airport using enormous chartered jets.

By the end of 2006. HonorAir had flown more than 300 WWII veterans to their memorial. His actions revolutionized the mass movement of these senior heroes to Washington D.C.

In February of 2007, Morse and Miller met in Washington, DC at the first "Summit" and merged Honor Flight and HonorAir into what is now known as the Honor Flight Network. By 2017, there were 140 Honor Flight Network regional hubs across the United States.

In the spring of 2008, Senator Bob Dole nominated both Earl Morse and Jeff Miller for the prestigious Presidential Citizens Medal. President George W. Bush in the Oval Office awarded the medal to Morse and Miller in December of 2008.

Applications for Honor Flight are available at the Veterans Service Office.

Modernization effort helps to speed up VA claims

The U.S. Department of Veterans Affairs (VA) recently completed a significant modernization effort in which more than 7.8 million paper files were removed from 60 locations in fewer than 22 months, enabling rapid scanning into VA's electronic claims processing system by multiple third-party vendors.

This will lead to faster claims decisions for Veterans.

This milestone was part of a long VA effort to improve the Veteran experience and streamline claims processes.

In 2013, VA began removing paper records from its regional offices to save space and taxpayer money. The effort expanded in 2016 when the agency



launched the File Bank Extraction initiative. This initiative removed more than 1.7 million paper claims files across 59 VA locations and contributed to reduced claims processing time by establishing more electronic records.

Additionally, in Nov. 2017, VA began extracting nearly 6.1 million paper records held within the Records Control Division (RCD) of the Records Management Center (RMC) in St. Louis.

VA is currently working with the General Services Administration (GSA), which owns the Goodfellow Federal Center complex that houses the RMC, to return the RCD's leased warehouse space back to GSA. As a result, VA will save nearly \$1.8 million per year.

The other areas of the RMC remain

The 6.1 million paper records extracted from the RCD are temporarily stored in a secure facility certified by the National Archives and Records Administration where they are inventoried, prioritized and sent to multiple VA vendors for rapid scanning into VA's Veterans Benefits Management System (VBMS).

Records removed during File Bank Extraction will also be scanned and uploaded to VBMS.

VA continues to take steps to operate in a digital environment and modernize the way it processes compensation and pension claims — moving from a cumbersome, paper-intensive process to an efficient, electronic process - resulting in a faster, more accurate and transparent claims process.
