## Veterans may be eligible for one more year of G.I. Bill benefits

Are you a Veteran who served at least two periods of service? In other words, did you reenlist? If so, there's a chance that you're eligible for additional G.I. Bill benefits.

<u>January 3, 2025</u>, VA announced that it has updated its process for awarding G.I. Bill benefits. This means that many Veterans who served multiple periods of military service (for example, Veterans who reenlisted) may be eligible for additional benefits for themselves or their beneficiaries.

Specifically, under the previous policy, eligible Veterans who served at least two periods of service were forced to choose between the Montgomery GI Bill and the Post-9/11 GI Bill for a maximum of 36 months of G.I. Bill benefits. Under the updated policy, Veterans will no longer have to make that choice when they apply for benefits, meaning that they can qualify for up to 48 months of G.I. Bill benefits.

Many Veterans are also now eligible for additional, retroactive benefits. Specifically, Veterans who served at least two periods of service—one that qualified them for the Montgomery G.I. Bill and a second that qualified them for the Post-9/11 G.I. Bill—may be eligible to receive up to 12 months of additional G.I. Bill benefits (bringing them to a total of 48 months). These Veterans may be eligible to receive 12 months of additional, retroactive G.I. Bill benefits (bringing them to a total of 48 months).

#### Who qualifies for this expansion?

Veterans who served at least two periods of service—one that qualifies for the Montgomery G.I. Bill and a second that qualifies for the Post-9/11 G.I. Bill—may be able to receive additional GI Bill® benefits.

#### Will I be notified if I'm eligible?

Yes, VA will be distributing communications to potentially impacted beneficiaries.

#### My G.I. Bill benefits expired. Will there be an extension if I'm found eligible?

To receive an expiration date extension, applications must be submitted by Oct. 1, 2030.

#### Do I need to do anything?

Of the 1.04 million Veterans who may potentially be eligible for additional benefits, VA will be able to automatically adjudicate the claims for approximately 660,000 without any further action required on their part. For all remaining Veterans, VA will be reaching out to them directly to encourage them to file a claim.

#### When is the deadline to apply for those who need to take action?

#### Oct. 1, 2030.

## VA expands access to Veterans Legacy Memorial, allowing Veterans to chronicle their life story

WASHINGTON — January 16, 2025, the Department of Veterans Affairs expanded the Veterans Legacy Memorial (VLM) — the nation's largest digital platform dedicated to the memory of Veterans and service members — to allow Veterans to tell their own story before they pass away. The new "Your Story, Your Legacy" feature will allow Veterans who have been approved for VA's pre-need eligibility determination for burial in a VA national cemetery to log in to a secure website where they can privately submit images, autobiographies, military and life milestones, and historical documents.

VLM already offers family, friends, and others a way to chronicle the life of a Veteran by uploading written tributes, photos, biographies, documents, and other information. It contains nearly 10 million interactive VLM pages for those interred in VA national cemeteries, Department of Defense-managed cemeteries, VA grant-funded state/tribal cemeteries, National Park Service cemeteries, and private cemeteries around the world.

VA will keep a Veteran's content secure until they pass away and VA approves a request for a burial or memorial benefit. Following approval, the content the Veteran submitted will become public and appear on their VLM page on the public-facing website.

"The legacies we leave behind come in many forms," said Acting Under Secretary for Memorial Affairs Ronald Walters. "Providing Veterans with resources to document their stories while they are still with us ensures their voices are heard and allows family members, friends, and others to appreciate the experiences of those who served."

Veterans who have provided their email address and been approved for pre-need eligibility will receive an email directing them to the "Your Story, Your Legacy" landing page. Here's where to apply online:

# VA makes several cancers presumptive for service connection – lowering the burden of proof for Veterans to receive no-cost health care and earned benefits

In a step that builds on the focus to fulfill the nation's sacred obligation to the nation's Veterans, the Department of Veterans Affairs announced that it is making acute and chronic leukemias, multiple myelomas, myelodysplastic syndromes, myelofibrosis, urinary bladder, ureter, and related genitourinary cancers presumptive for service-connection for:

**Gulf War Veterans**: Veterans who served in Somalia or the Southwest Asia theater of operations (which includes Iraq, Kuwait, Saudi Arabia, the neutral zone between Iraq and Saudi Arabia, Bahrain, Qatar, the United Arab Emirates, Oman, the Gulf of Aden, the Gulf of Oman, the Persian Gulf, the Arabian Sea, the Red Sea, and the airspace above these locations) during the Persian Gulf War on or after Aug. 2, 1990.

**Post-9/11 Veterans:** Veterans who served in Afghanistan, Iraq, Djibouti, Egypt, Jordan, Lebanon, Syria, Yemen, or Uzbekistan and the air-space above these locations during the Gulf War on or after Sept. 11, 2001. This includes Veterans who served at the Karshi-Khanabad (K2) base in Uzbekistan after Sept. 11, 2001.

This step lowers the burden of proof for these Veterans, meaning that they do not need to prove that their service caused their condition to receive benefits for it. Instead, VA automatically assumes service connection for the condition and provides benefits accordingly. Additionally, when a Veteran becomes service connected for a health condition, it gives them access to free health care for that condition. The presumptions for urinary bladder, ureter, and related genitourinary cancers went into effect Jan. 2, 2025, and the presumptions for acute and chronic leukemias, multiple myelomas, and myelodysplastic syndromes, myelofibrosis will be effective Jan. 10, 2025.

This expansion is part of a comprehensive, yearslong effort by VA to expand access to benefits for Veterans. In 2022, President Biden signed the PACT Act into law — the largest expansion of Veteran benefits in generations. VA then made millions of Veterans eligible for health care and benefits years earlier than called for by the law and launched the largest outreach campaign in VA history to encourage Veterans to apply. As a result, VA is currently delivering more care and more benefits to more Veterans than ever before — and earning Veteran trust at record rates.

"At VA, our goal is to provide every Veteran with the care and benefits that they've earned for their service to our nation — and that's what this is all about," said VA Secretary Denis McDonough. "Adding these presumptives lowers the burden of proof for Veterans to get the benefits they deserve for the conditions that followed them home from war. We encourage Veterans with these conditions — and all Veterans — to apply today for the benefits they deserve today."

Since the PACT Act was signed into law, VA has conducted the largest outreach campaign in VA history to ensure that Veterans are signing up for the care and benefits they are newly eligible for. As a result of this effort, nearly 890,000 Veterans have signed up for VA care since the bill was signed into law (a nearly 40% increase over the previous equivalent period) and Veterans have submitted more than 4.8 million applications for VA benefits (an 42% increase over the previous equivalent period and an all-time record). In total, more than 1.3 million Veterans have enrolled in VA health care since President Biden took office in 2021, and VA has delivered more than \$600 billion in earned benefits directly to Veterans, their families, and survivors during that time.

In addition to supporting all Veterans who served during the Gulf War, Iraq War, and Afghanistan War, these steps are also a part of a comprehensive effort VA is undertaking to listen to Veterans who served at the Karshi-Khanabad base and ensure that VA is providing them — and their survivors — with the care and benefits they deserve. Partly as a result of these efforts, K2 Veterans have higher claim and approval rates than any other cohort of Veterans: 13,002 K2 Veterans of the approximately 16,000 known K2 Veterans are currently enrolled in VA health care, more than 11,800 are service connected for at least one condition, the average K2 Veteran is service connected for 14.6 conditions at a 70% disability rating, and the average service-connected K2 Veteran receives an average of \$30,000 a year in earned benefits. VA continues to work to ensure that all K2 Veterans get access to the benefits they deserve.

VA encourages Veterans with these conditions to apply for benefits today, and encourages eligible Veterans with previously denied claims to reapply. VA will update publicly available information and conduct general outreach to Veterans and survivors to publicize this new eligibility and how to apply. # Prepare for VA's secure sign-in changes

In 2025, you'll need to start using a Login.gov or ID.me account to sign in.



#### Why this matters to you

In 2025, you'll have 2 secure sign-in account options (Login.gov and ID.me) for all VA websites and apps. We'll remove the My HealtheVet option after March 4, 2025, and the DS Logon option after September 30, 2025. You'll still be able to use your My HealtheVet health portal—you'll just need to sign in to it with a Login.gov or ID.me account.

#### Create a Login.gov or ID.me account now

We encourage you to create a Login.gov or ID.me account now. If you already have one of these accounts but haven't yet used it, start now so you have time to get used to it before the change. With Login.gov or ID.me, you'll have access to all the same information and services you use today.



We are not the VA. We are YOUR County Veterans Service Officers assisting veterans to navigate the VA. We are affiliated with the VA through our accreditations with National Service Organizations: VFW, DAV, American Legion, & Ohio Department of Veterans Services.

Who we are and what we do: The Veterans Service Commission, formerly called the Soldier's & Sailors Relief Commission, was established by the Ohio General Assembly in 1886. Title 59, Chapter 5901 of the Ohio Revised Code, establishes and regulates the operation of the Commission, and accordingly, the Coshocton County Veterans Service Commission is empowered to provide temporary assistance to veterans, their spouses, their dependents, and their widows and orphans.

It is the goal of the Coshocton County Veterans Service Office to inform our veterans of their benefits, transport them to VA medical care facilities, provide short-term financial assistance, and act as an agent in obtaining assistance from federal, state, or local agencies.

THIS POLICY IS DIFFERENT FROM THE PREVIOUS 72 HOUR NOTICE POLICY IN THAT THIS IS A CENTRALIZED SYSTEM REGARDLESS OF WHERE THE VETERAN IS AT OR THE CLINIC THEY NORMALLY SEE.
